## LIFETIME LIMITED TRANSFERABLE WARRANTY

Because of NewSouth's single source accountability, all NewSouth windows featuring iVantage™ glass, eVantage™ glass, and high performance patio doors are **GUARANTEED FOR AS LONG AS YOU OWN THEM...PLUS 1 YEAR TRANSFER TO THE NEXT OWNER.**

NewSouth Window Solutions warrants to the original purchaser of its high performance windows that there will be **NO CHARGE** for any necessary **REPAIR, PARTS, LABOR OR MATERIAL**, due to any **MANUFACTURING or INSTALLATION** defect with your NewSouth high performance windows and patio doors. NewSouth shall, at its sole option, (1) refinish the product or (2) repair or replace the affected product or component, or (3) refund the product. Service refinishing, or service repairs are warranted for the remainder of the original limited warranty period. Bronze and/or black finish will be warranted for 10 years from the date of installation against cracking, peeling, chalking, delaminating, blistering, flaking and significant ultraviolet discoloration caused by natural environmental atmospheric conditions unaffected by acts of God, fire, civil disorders, war, or unreasonable use, abuse or misuse.

This warranty can be transferred one (1) time to a subsequent owner. The additional warranty period will be one year from the date of sale of the property to the next owner. The original purchaser must notify NewSouth of the date of the property sale and the new homeowner's name within 30 days of the sale date. If the Product fails to conform to the Limited Warranty while owned by the original purchaser or during the additional warranty period after transfer to a subsequent owner, NewSouth will, at its sole discretion, either repair the Product or install a replacement product of equal or greater value. This is the sole and exclusive remedy available to the original purchaser or to the first subsequent owner during the additional warranty period for breach of this warranty.

**ADDITIONALLY, IN ACCORDANCE WITH THE TERMS OF THIS WARRANTY:**

**NO CHARGE** will be made for **BROKEN GLASS**. **NO CHARGE** will be made for **GLASS SEAL FAILURE**. **NO CHARGE** will be made for **SCREEN REPAIR**.

There is a nominal trip charge after two years for all service calls.
